Announcement

Important updates for families receiving Child Care Subsidy

EFFECTIVE Jan. 1, 2026: Families receiving childcare subsidy will be responsible for paying their required co-payments and any overage amounts, which are based on household size and income, directly to their childcare provider.

The amount of your co-pay depends on your household size and income as indicated on the sliding fee scale above.

OVERAGES:

The overage is the difference between what your provider charges and the BCCS maximum rate for your child's age group. Your co-pay is added to this amount, and together they total what you'll pay out of pocket.
